Kerala Infrastructure Investment Fund Board (KIIFB), a statutory body under Finance Department, Government of Kerala, invites application from qualified and competent candidates for appointment to various posts, **on contract basis for a period of One year**. Interested candidates may apply via **ONLINE** mode only by filling the prescribed application form given in the website of Centre for Management Development (CMD), Thiruvananthapuram (www.cmdkerala.net). The online application submission link will open on **16.05.2018 (9.00 am)**. The last date for submitting the online application will be **30.05.2018 (5.00 pm)**.

Note: Candidates will have to upload their passport size photograph (taken within six months), signature and copies of certificates proving qualification and experience while submitting the application. The photograph and signature must be in JPEG format. The size of the photograph must be less than 200 kb and the size of the signature should be less than 50 kb. The copies of certificates shall be either in JPEG format or in PDF format, and shall not exceed 3mb size.
