STIPEND DURING TRAINING PERIOD; ₹ 18000/- per month

BOND

Selected candidates will have to execute a Bond to serve the Company for a minimum period of 5 years after successful completion of training.

MAXIMUM AGE LIMIT

Not more than 35 years as on 1st June 2020. Usual relaxation will be allowed to SC/ST/OBC candidates as per Company's/Government rules from time to time.
